



General Community Center Rules & Regulations

The following guidelines have been established to allow for the greatest enjoyment of the Jerome Village Community Center (JVCC). The comfort and convenience of members, their families, and their guests is best served by observance of the Rules and Regulations. As a reminder, members are responsible for their own actions and those of their families and their guests, and therefore members are liable for any loss or damage to the JVCC property caused by their family and guests. The member is responsible for all indebtedness incurred by their family and guests while using the facilities, and the JVCC assumes no responsibility for loss or damage to members' or guests' personal property.

1. All furnishings and equipment of the JVCC are intended for exclusive use on the JVCC property for the enjoyment of members and their guests and may not be removed or borrowed from the Community Center premises without the written consent of the JVCC Management.
2. No outside food or beverage may be brought onto the premises.
3. Parents are responsible for monitoring their child(ren)'s behavior onsite at the JVCC at all times.
4. Animals are not permitted on the premises, other than service animals.
5. Smoking is not permitted within 100 feet of the JVCC building or pool.
6. All vehicles must be operated at safe speeds on the property. The JVCC is not responsible for loss or damage to vehicles parked in the parking lot. The JVCC assumes no responsibility for personal property or articles left in vehicles.
7. No subscription, petition or notice other than JVCC notices shall be circulated or posted on the Community Center premises.
8. No member or JVCC employee shall be permitted to issue any press release or publish articles about the JVCC operations, unless such publicity or information is first approved by the JVCC Manager and/or Jerome Village CDA.
9. Alcoholic beverages shall not be ordered by or for, or served to anyone under the age of 21.
10. The responsibility for the conduct of each member, his or her family and guests, with respect to the consumption of alcoholic beverages on the premises of the Community Center and in operating motor vehicles following such consumption, lies with the individual member, and is not and cannot be assumed by the JVCC or Jerome Village CDA.
11. Members may reserve some spaces for private functions. Pool, Barn and East Lawn spaces are available to rent, subject to availability. Arrangements can be made with the JVCC Management or Food Service Operator. Space rental fees will apply.
12. Members are requested to report violations of the rules to JVCC Management. Violation of the Community Center Rules shall subject the member involved to censure, reprimand, suspension, expulsion, or other disciplinary action as may be deemed appropriate by JVCC Management or Jerome Village CDA.

JEROME VILLAGE

Swimming Pool Rules & Regulations

To use the pool area, ALL MEMBERS ARE REQUIRED TO CARRY AND PRESENT THEIR JVCC I.D. CARD WHEN ASKED. The pool may close early on days of special events. Early closings will be posted in advance.

1. No large rafts or balls will be permitted in the pool. Coast-Guard approved flotation devices are permitted, as well as small pool toys such as diving sticks and goggles.
2. No flotation devices can be used while jumping off a board. Diving is not permitted.
3. No running, pushing, dunking, wrestling, splashing, throwing of objects, or use of foul language will be permitted. Anyone who chooses not to abide by this rule will be asked to exit the pool.
4. Children under 12 years old must be accompanied by a responsible person who is 16 or older.
5. Children that are not toilet trained are required to wear swim diapers in the pool at all times. Regular/non-swim diapers are not permitted in the pool.
6. All visitors, at a minimum, must wear swim/bathing suits. Safety suits for small children are permitted. A variance may be requested for medical or religious reasons. Such a variance will require reasonable information to support request and community center staff approval. Persons leaving the Swimming Pool area to enter the JVCC must wear appropriate covering over bathing suits and shoes.
7. Excessive use of lotions and creams prior to entering the pool is strongly discouraged.
8. A rest period will be enforced at quarter till each hour. At that time, all swimmers must exit the pool, and the pool will be closed until the top of the hour.
9. No glass containers will be allowed in the pool or the pool area. Any broken glass will result in the pool being closed and drained. If the pool must be drained, the responsible member will be charged a fee related to those costs.
10. Alcoholic beverages are available for purchase at the restaurant and concession stand and may be consumed in the pool deck area. Drunk and disorderly conduct will not be tolerated.
11. Closings due to mechanical failures or chemical levels are inevitable. Every attempt will be made to reopen the pool as soon as possible.
12. Please contact JVCC Management or call 911 for any emergencies.

Guest Pool Policies

1. Guests, defined as anyone who does not reside in the household of the JVCC member and is not registered on the application, are permitted when accompanied by a member.
2. It is the responsibility of every member to register their pool guests and pay the appropriate fees. Failure to register guests will result in disciplinary action. Guests must be registered upon entry to the pool area.
3. The daily guest fee for the swimming pool is \$8.00* per person per day. Children under 3 years of age are free. Daily guest wristbands must be purchased at the concession stand upon arriving at the pool.
4. Each member in a household has the option to add one named guest to their pool membership for \$100.00 for the duration of the calendar pool season. This Seasonal Guest I.D. must be purchased through the JVCC Management. Payment may be made by check only.

*Fees can be paid via check or credit card.



Fitness Center Rules & Regulations

Fitness Center Hours: Keycard access from 5 am- 9 pm daily. Fitness facilities, including shower and locker rooms, are only accessible during posted hours.

1. Only members of the JVCC age 14 years or older may have access to the fitness area and equipment.
2. Permission to use the fitness area is expressly conditioned upon registration and the signing of a release form. Prior to use, parents must sign a release form on behalf of children ages 14-17.
3. The fitness area is for member use only. Members must use their keycard to enter fitness area. No guests are permitted, including personal trainers.
4. Dangerous or disruptive behavior will cause privileges to be suspended.
5. Food and glass containers are not permitted in the fitness area.
6. Members must pick up towels, magazines, water bottles, etc. when finished.
7. To increase the longevity and accessibility of the fitness equipment, please abide by the following:
 - a. Do not drop weights on the floor.
 - b. Keep weights off vinyl benches.
 - c. Return and rack weights when finished.
 - d. Return mats and medicine balls when finished.
 - e. Ease the weights into position on the machines to avoid them crashing down.
 - f. If you need assistance, please find a JVCC employee.
8. Please use a towel to wipe down equipment after you have finished using each machine.
9. Proper athletic wear is required in fitness area. Shirts must be worn at all times. Clothing with offensive wording and/or symbols are NOT permitted.
10. Appropriate athletic shoes that are clean and dry must be worn. Sandals and flip-flops are not permitted. During times of inclement weather, it is recommended that residents bring shoes to change into once they've arrived at the fitness center to keep floors clean and dry.
11. Lockers are available on a first come, first serve basis. Members must provide their own lock. Lockers are for "day use" during hours of operation only. Locks must be removed each evening. Management may remove any lock left on a locker overnight. Any contents left in a locker afterhours will be disposed of and the JVCC will not be held responsible for such items
12. If the fitness center must be temporarily closed for routine or emergency maintenance, residents will not be reimbursed any fees.
